I am directed to refer to your letter no JDDU-UMC PvT dated 01.09.2017 on the above mentioned subject and to convey this Ministry's 'no objection' in principle for obtaining **Conference Visa** for foreign participants in the above mentioned event(s) subject to usual checks as prescribed.

2. The organisers are also requested to obtain Political clearance from Ministry of External Affairs and necessary clearance from various other authorities in connection with the event.
3. The foreign participant should submit online application for visa at [www.indianvisaonline.gov.in](http://www.indianvisaonline.gov.in) immediately.
4. Indian Missions abroad are authorized to issue **Conference Visa** to delegates on production of an invitation letter from the organizer(s), a copy of this letter and a copy of the communication from the Ministry of External Affairs conveying political clearance.
5. However, Visa for participants from (1)Afghanistan (2)Iraq, (3)Pakistan (4)Sudan (5)Foreigners of Pakistani origin and (6)Stateless persons can be issued only after MHA Clearance. Therefore, online application for Visa must be made at least 60 days in advance. Simultaneously, information about the participants from these countries should also be made available to the Foreigners Division, Ministry of Home Affairs in the format given below:


